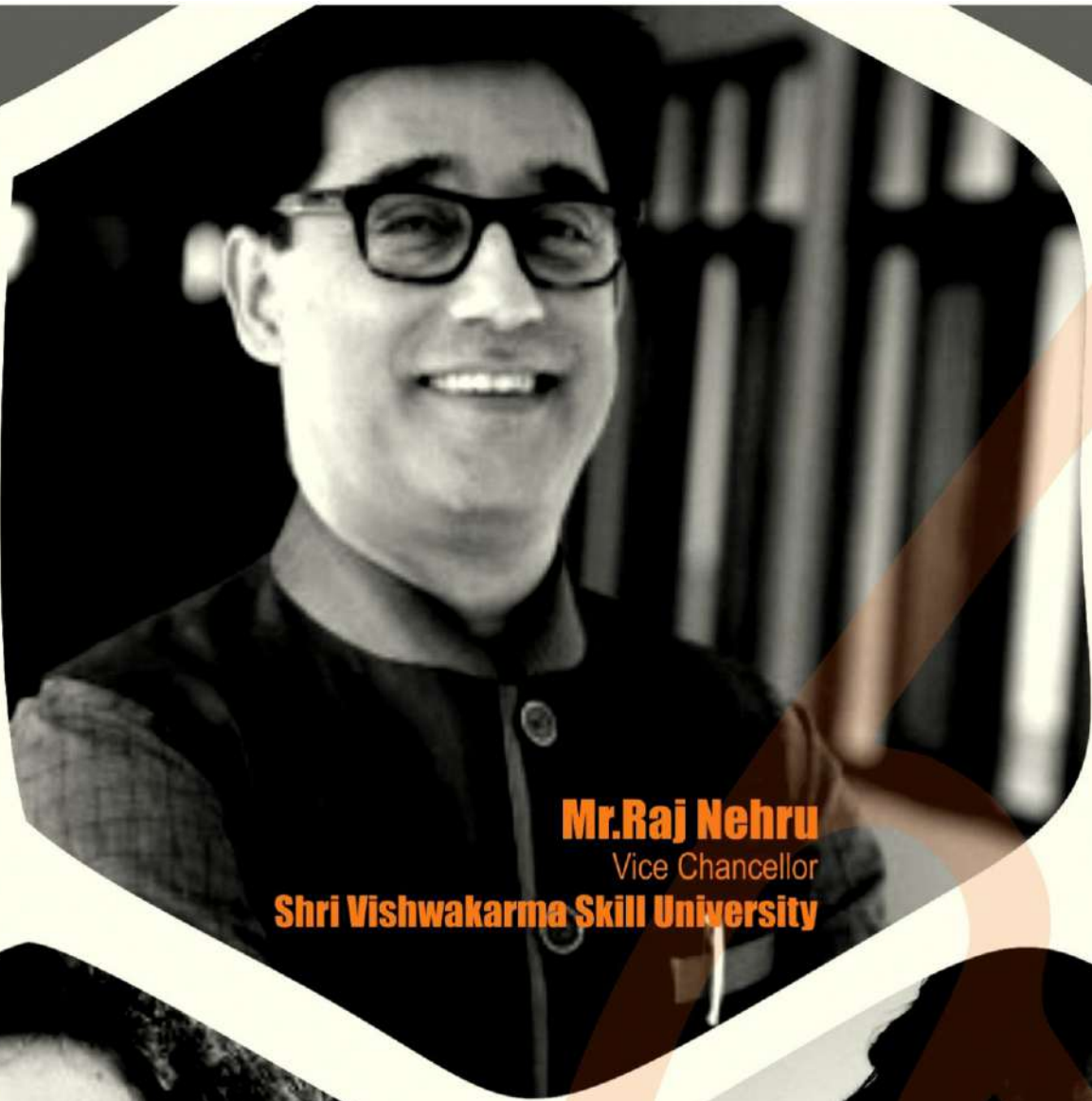

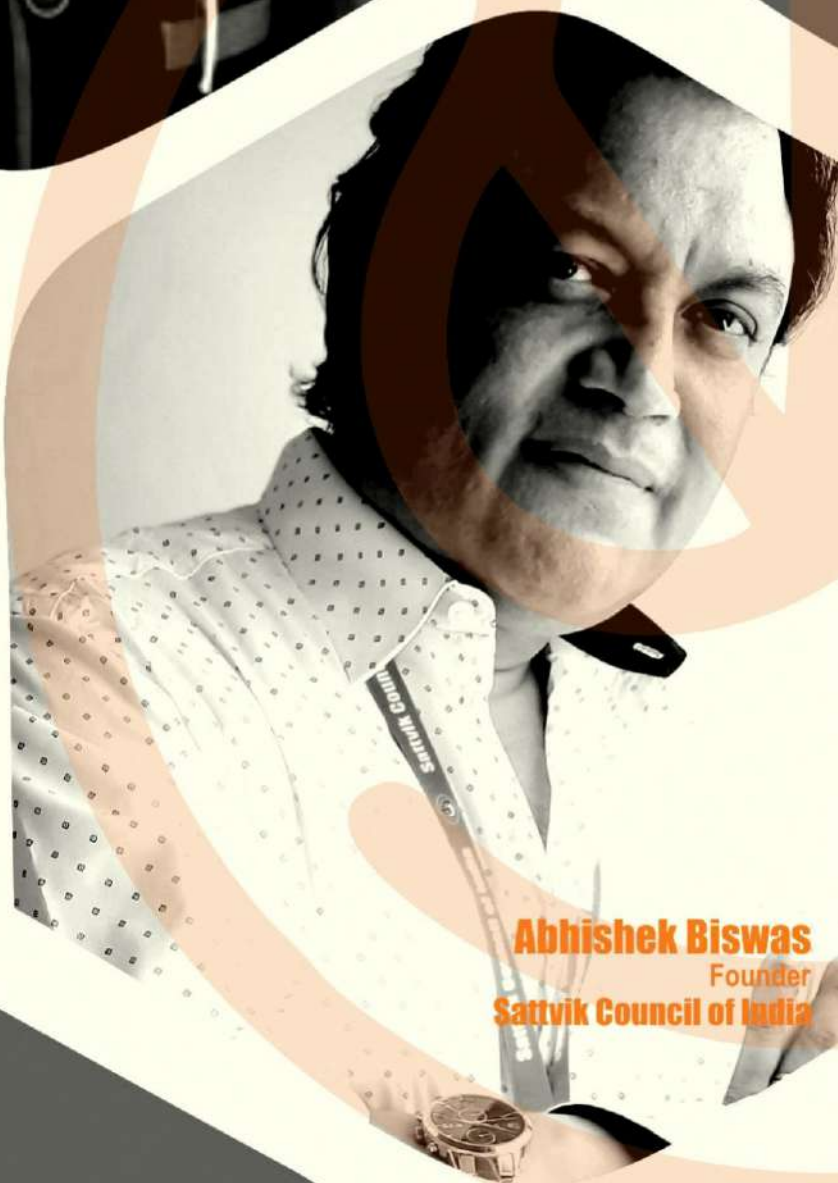

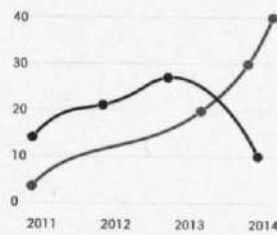
Education and training play a crucial role in enabling young people, in particular, to develop these competences and, thereby, provide the conditions for the best possible start in life.

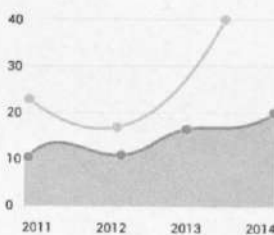

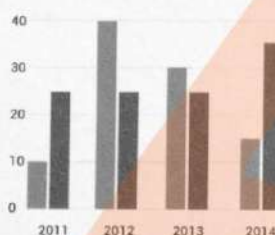

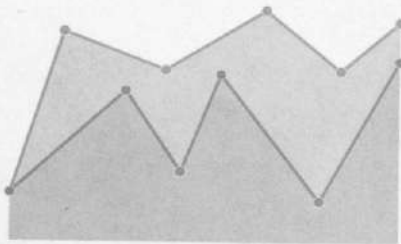


Donut Chart

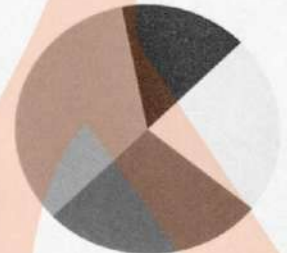
